For those who take the final exam in the winter, the thesis submission deadline is 20 November. The technical details regarding the submission are contained in the thesis submission guide available on the website of the TOK Office of Educational Affairs.</p> <p>(1a) Prior to uploading the thesis, the Student must submit a thesis acceptance request to the supervisor in the Electronic Study System. The thesis can be uploaded only after the electronic approval of the supervisor. The deadline for submitting the thesis acceptance request is 10:00 am on the working day before the thesis submission deadline (18 November 10:00 am)</p> <p>(2) The submission deadline of the thesis cannot be modified. Exceeding the deadline or not getting a pass grade for the preliminary review shall result in the cancellation of the final exam registration</p> <p>The preliminary thesis review will also be uploaded to Neptun.</p>
Obtaining the final certificate (absolutorium)	16 January 2023 23:59	Neptun	<p>Based on Section 493 (1a) of the Academic Regulations for Students: The student may be allowed to take the final exam, if he/she has fulfilled all the academic requirements necessary for the final (pre-degree) certificate. The results have to be recorded in Neptun at least 10 days prior to the final examination period.</p> <p>If the student doesn't obtain his/her final certificate until the designated deadline, he/she cannot take the final exam.</p>

The final exam will foreseeably be held in person, in the designated rooms of Gyertyánffy István Practice School next to the TÓK Faculty Building.

The day of the final exam is not designated according to the student's request or choice: the exact time and venue of the final exam, the detailed schedule will be published on the [Student Affairs Office>For Current Students>Final Exam](#) website on **19 January 2023**. In the schedule, the students' educational IDs will be listed. The individual educational ID can be found in the final exam registration form as well as in Neptun under **My data/Personal information**.

The registration for the final exam can be withdrawn free of charge until **18 January 2023 16:00**: the withdrawal request shall be sent to th@tok.elte.hu

Act CCIV of 2011 on National Higher Education Article 50(1):

The higher education institution shall issue a **final certificate (absolutorium)** to students who have fulfilled the study and examination requirements prescribed in the curriculum, completed the required practice period and acquired the required number of credits.

Please check your completed and current courses in Neptun! If you find that some courses or credits are missing, you may submit a late course registration request until the deadline defined in Section 62/A of the Academic Regulations for Students

The student status gets terminated on the last day of the semester in which the final certificate is obtained: the last day of the autumn semester is **31 January**

According to Section 81(6) of the Academic Regulations for Students:

Students who

c) started their studies in accordance with Act CCIV of 2011 on Hungarian National Higher Education, that is, on or after 1 September 2012, may take their final exam during any exam period **within 2 years** of the expiry of their student status, in line with the valid training requirements. Taking the final exam more than 2 years after the issuance of their final certificate, however, may be subject to certain conditions established by the University. Students who started their studies in accordance with Act CCIV of 2011 on Hungarian National Higher Education shall not be granted permission to take the final exam **more than 5 years** after the expiry of their student status

The student can take the final exam if he or she:

- registers for the final exam until the designated deadline
- obtains his/her final certificate (absolutorium)
- submits his/her degree thesis until the deadline defined in Section 491(1) of the Academic Regulations for Students and the grade of his/her preliminary thesis review is at least pass
- does not owe any debts towards the University or the Faculty Library

Since the personal data in the diploma and the diploma supplement are taken from Neptun (name, date and place of birth, etc.), we kindly ask you to check them. If you find incorrect data in the issued diploma and its supplement, we will charge a fee for the correction.

You can request the modification of your personal data free of charge until the first day of the final examination period: 25 January 2023.

A certificate about the diploma being issued may be requested five working days after the final exam.
