The technical details regarding the submission are contained in the thesis submission guide available on the website of the TOK Office of Educational Affairs. (1a) Prior to uploading the thesis, the Student must submit a thesis acceptance request to the supervisor in the Electronic Study System. The thesis can be uploaded only after the electronic approval of the supervisor. The deadline for submitting the thesis acceptance request is 10:00 AM on the last workday before the thesis cannot be modified. Exceeding the deadline or not getting a pass grade for the preliminary review shall result in the cancellation of the final exam registration The thesis and the preliminary review shall both be uploaded to Neptun |
| Obtaining the final certificate (absolutorium) | 23 May 2024 23:59 CET | Neptun | Based on Section 493 (1a) of the Academic Regulations for Students: The student may be allowed to take the final exam, if they have fulfilled all the academic requirements necessary for the final (pre-degree) certificate. The results have to be recorded in Neptun at least 10 days prior to the final examination period. If the student doesn't obtain their final certificate until the designated deadline, they cannot take the final exam. |

Act CCIV of 2011 on National Higher Education Article 50(1):

The higher education institution shall issue a **final certificate (absolutorium)** to students who have fulfilled the study and examination requirements prescribed in the curriculum, completed the required practice period and acquired the required number of credits.

Please check your completed and current courses in Neptun! If you find that some courses or credits are missing, you may submit a late course registration request until the deadline defined in Section 62/A of the Academic Regulations for Students.

The student status gets terminated on the last day of the semester in which the final certificate is obtained: the last day of the spring semester is June 30

According to Section 81(6) of the Academic Regulations for Students:

Students who

c) started their studies in accordance with Act CCIV of 2011 on Hungarian National Higher Education, that is, on or after 1 September 2012, may take their final exam during any exam period **within 2 years** of the expiry of their student status, in line with the valid training requirements. Taking the final exam more than 2 years after the issuance of their final certificate, however, may be subject to certain conditions established by the University. Students who started their studies in accordance with Act CCIV of 2011 on Hungarian National Higher Education shall not be granted permission to take the final exam **more than 5 years** after the expiry of their student status.

The student can take the final exam if he/she:

- registered for the final exam until the designated deadline
- has obtained the final certificate (absolutorium)

- submitted the degree thesis until the deadline defined in Section 491(1) of the Academic Regulations for Students and the grade of the preliminary thesis review is at least pass
- has no debts towards the University or the Faculty Library

Since the personal data in the diploma and the diploma supplement are taken from Neptun (name, date and place of birth, etc.), we kindly ask you to check them. If you find incorrect data in the issued diploma and its supplement, we will charge a fee for the correction.

You can request the modification of your personal data until the first day of the final examination period: 3 June 2024. Modification requests sent after the above-mentioned deadline entail the charge of a late fee and it is likely that the diploma will not be issued until the graduation ceremony.

A certificate about the diploma being issued may be requested five workdays after the final exam.
